## NOTICE TO ALL FOOD VENDORS

In order to ensure the unique quality of Camelot Days, all food vendors must have prior approval of all items to be sold. Every item, beverage and food should be clearly listed on the Festival Application.

Vehicles and trailers are not permitted in the Park during Festival hours and may not be used to dispense products without prior written approval of the Camelot Days director.

Vendors must clean up their areas during and at the end of Festival. Trash and garbage generated in the production of food must be in plastic bags. Oils and grease must be in sealed non-spill containers. Cooking oil and charcoal must not be dumped on the ground.

Remember to fill out your application completely, including your list of all items for sale. **Items not listed and approved on your application cannot be sold!** Your cooperation in operating an attractive renaissance-decorated, clean booth will be appreciated.

You are required to have Liability Insurance and a valid Food Sale Permit from the Broward County Public Health Department for this event.
